Statement of Revenue and Expenditures

5. LEGISLATION / GOVERNMENT RELATIONS

Construction Advisory Panel Meeting (Virtual Meeting Held)

NCLRA Chair Tony Fanelli advised that during the April 7, 2021 meeting there was extensive discussion relating to:

Canadian Building Trades Unions (CBTU)

- Agreement with CLRA Building Trades to work together as they each work with different Labour Relations Laws. Re-engagement to take place in early May.
- Dialog is essential to support us on national issues and to help us on provincial issues. Overall, we can expect a lot of good things to come out of this collaboration. For example: tax deductions.

Trades Training

- Some of the NCLRA members are advising that their provincial governments are looking seriously at moving trade's micro credentialing.
- It was noted that this is what occurred in B.C. as well as the elimination of all classified trades. It now appears that B.C. may be moving away from this model.
- This led to discussion as to what is the status of the Sherrard Skilled Trades Panel report in Ontario. The secretary was directed to investigate the status of the panel's report.

The NCLRA convention is to be held in Las Vegas in September 2022.
