Re: Request for Increased Funding to Support De Novo's Vital Services

Dear Mr. Peterson and Members of the CECCO,

De Novo is an accredited alcohol and drug treatment service that operates as a partnership between Ontario's unionized construction trades and management. With a volunteer board of directors equally composed of union and management representatives, De Novo has been a trusted resource for over thirty years, providing support to unionized tradespeople, management teams, and their families as they navigate the challenges of substance use disorders.

We are reaching out to request your support in increasing the funding model for our services during the upcoming ICI collective bargaining process. Specifically, we are proposing an increase to 5 cents per hour from the union member, matched by 5 cents from the employer to a total of 10 cents per hour—up from the current funding rate, which has remained unchanged for the past 30 years. This funding increase is necessary to ensure De Novo can continue delivering high-quality care in the face of rising operational costs, especially food costs, and exponential increases in the demands from unionized tradespeople, management and their families for De Novo's services. We have had our treatment centre at full capacity with a waiting list for the last two years. We expect the demand for De Novo's services to continue to increase.

For decades, De Novo has operated without any government funding for client services, maintaining our high service standards despite financial pressures. In recent years, we have expanded our support to industry research on addiction and suicide within the unionized construction industry - these studies were funded by five government grants. The insights from this research will help enhance our services and strengthen the overall addiction treatment landscape for our clients.

This is an important "built by industry for industry" — Health Care Provider. De Novo has doubled its capacity since 2019 and has been praised for its good work by the current and past Labour Ministers.

De Novo's services extend to union members, their spouses and significant others as well as youth through a trusted third-party provider. Through our partnership with employer associations, which match funding, we are also able to offer these vital services to management employees and their families.

Having served the unionized construction industry for over three decades, De Novo is now seeking your partnership to increase funding through the ICI collective bargaining process. Your support will ensure that we can continue to meet the growing needs of the industry and provide essential services to those impacted by substance use disorders. De Novo's funding need is 5 cents from the employee and 5 cents from the employer—a total of 10 cents per hour. This is the funding that will keep De Novo operating.
