CECCO – COMMUNICATIONS UPDATE January 30, 2025

Dear Members -

I wanted to take an opportunity to reiterate some of the communications discussions that took place at our Sober Second Thoughts meeting and provide some further updates.

As you know, the election was called yesterday. Premier Doug Ford had his official campaign launch in Windsor, surrounded by tradespeople. In addition, there is a tradesperson photo on the side of his campaign bus. I think it is appropriate to interpret this as reinforcing his commitment to construction, and construction unions.

Coming out of the meeting, one of the things we heard was the need to make sure that contractors and those on the front lines with union members are aware of bargaining and have some speaking points ready. With that in mind, we will be distributing a document called "Talking About Facts", that EBAs can share with your contractors. The facts we will provide will be very simple, but will provide some talking points for your contractors/employers. You can expect the first notice next week. (Special thanks to Caitlin from EPSCA for the phrase "Talking About Facts").

Another item we discussed was momentum. Specifically, how we can start to create momentum by celebrating our successes. This allows us to get the message out that we are achieving agreements and manage the expectations of union members and contractors as other EBAs complete their bargaining.
