### **Anthony Dimaio** (June 2019)

Anthony has over 25 years of labour relations experience working as a staff representative for the United Food and Commercial Workers Union and most recently as a senior staff representative with the Canadian Media Guild. Anthony's long tenure as a labour relations practitioner has come from his philosophy that developing strong relationships is the foundation of everything he does, both professionally and personally.
