Good afternoon.

 $\mathcal{T}$ This morning, we discussed the allowable CRA mileage reimbursement rates.

Reviewing the information discussed we find that the word document attached is the allowable rate for our purposes.

The mileage allowance that **private sector employers** utilize is from the Department of Finance through the Income Tax Act which sets out reasonable allowances/reimbursements for employees to compensate them for the use of their motor vehicle in "connection with or in the course of their office or employment duties. The allowance may not be taxable if the per-kilometre rate is reasonable, and all other conditions are met." This is frequently referred to as the CRA rate. (\$0.72 on first 5000 km, \$0.66 thereafter)

The PDF document is from the National Joint Committee and specific to the Public Service of Canada (so Federal government employees).

"The National Joint Council of the Public Service of Canada is the Forum of Choice for co-development, consultation and information sharing between the government as employer and public service bargaining agents. Through the National Joint Council (NJC), the parties work together to resolve problems and establish terms of employment that apply across the public service.
